You are invited to apply for membership of the Cued Speech Association UK.

The Association is a registered charity whose aims are to promote, maintain and advance education in Cued Speech in the United Kingdom for use with and among deaf and hearing-impaired children and adults.

- Activities of the Cued Speech Association UK include the organisation of lectures, instruction in Cued Speech, giving advice on matters concerning education, using Cued Speech and maintaining contact with other similar organisations.
- Members are entitled to receive a newsletter four times each year and to attend and vote at the Annual General Meeting.
- Anyone interested in Cued Speech is eligible for membership. An ability to cue is not a necessary qualification.

The minimum annual subscription for membership is £10.

This subscription entitles the member to one year's membership to run from 1st January to 31st December. Those who apply for membership in the second half of the year will enjoy a period of membership free of charge, as membership renewal would not apply until the end of December the following year.

Cued Speech, devised by the late Professor R Orin Cornett in 1966, is a simple sound-based system comprising eight handshapes, used in four positions near the mouth, in conjunction with lip patterns so as to make all the sounds of spoken language fully comprehensible to deaf and hearing-impaired people.
